

### Benefits You're Entitled to if You Live in a NYC Shelter:

## **APARTMENT SEARCH CARFARE**

A legal information resource by the Legal Clinic for the Homeless

#### What is Apartment Search Carfare and what are the requirements to receive it?

Apartment Search Carfare is money the Human Resources Administration (<u>HRA</u>) provides to help residents of NYC shelters look for permanent housing. If you qualify, HRA will issue \$75.39 to your EBT card every month. To receive this money, you must meet the following requirements:

- 1. You must have an open Cash Assistance (welfare) case
- 2. You must NOT be receiving any other carfare allowance from HRA
- 3. Your apartment search activities are monitored by shelter staff
- 4. Your gross employment or other income, if any, is NOT over 200% of the federal poverty level for your household size. (In 2023, 200% of the federal poverty level for a family of two is \$36,620 per year.)

# How do I request retroactive and ongoing Apartment Search Carfare if HRA does not provide it to me?

- 1. Complete the HRA Additional Allowance Request Form found here.
- In the "other" box on page 2, write: "Requesting Apartment Search Carfare from the date I moved into shelter on (\_\_/\_\_/202\_\_) (fill in the date) and the addition of the carfare to my budget
- 3. Sign, date, and upload the completed form to your <u>ACCESS HRA</u> mobile app AND/OR bring or mail the form to your Benefit Access Center.
- 4. Keep copies of all documents submitted to HRA.

If you cannot submit the form using the methods described above, you can

- 1. Ask HRA to take your request by calling 718-557-1399 OR
- 2. Visit your HRA Benefit Access Center and submit your request at the location

### What should I do if HRA does not give me the Apartment Search Carfare I am eligible for from the date I entered shelter?

You can request a State Fair Hearing using one the methods below:
